

# COMMITTEE REPORT

## MADAM PRESIDENT:

**The Senate Committee on Education and Career Development, to which was referred House Bill No. 1005, has had the same under consideration and begs leave to report the same back to the Senate with the recommendation that said bill be AMENDED as follows:**

- 1 Page 3, line 4, delete "meet" and insert "**communicate**".
- 2 Page 3, line 10, delete "plan to meet the" and insert "**develop an**
- 3 **individual remediation plan.**".
- 4 Page 3, delete line 11.
- 5 Page 9, line 9, delete "2013," and insert "**2014,**".
- 6 Page 9, line 9, delete "state board," and insert "**department,**".
- 7 Page 9, line 11, after "IC 20-19-4-2;" insert "**and**".
- 8 Page 9, delete lines 12 through 13.
- 9 Page 9, line 14, delete "(3)" and insert "**(2)**".
- 10 Page 9, line 15, delete "and".
- 11 Page 9, delete line 16.
- 12 Page 9, line 21, after "graduation." insert "**Guidelines developed**
- 13 **under this section must be approved by the state board.**".
- 14 Page 9, line 27, after "program;" insert "**and**".
- 15 Page 9, delete lines 28 through 38.
- 16 Page 9, line 39, delete "(3)" and insert "**(2)**".
- 17 Page 10, delete lines 6 through 42, begin a new paragraph and
- 18 insert:
- 19 "**Sec. 3. (a) The department shall identify secondary schools that**
- 20 **have a three (3) year graduation waiver rate that is higher than the**

1 average three (3) year graduation waiver rate for all public  
 2 secondary schools in the state by a percentage determined under  
 3 subsection (b).

4 (b) After analyzing data collected from all schools in the state,  
 5 the department shall recommend to the state board for the state  
 6 board's approval a percentage for use under subsection (a). The  
 7 state board, after considering the department's recommendation,  
 8 shall determine the percentage that is to be used under subsection  
 9 (a).

10 (c) The department shall make the first identification of schools  
 11 to be placed on notice under section 4 of this chapter for the  
 12 2016-2017 school year.

13 **Sec. 4. (a) This section applies the first year a school is identified**  
 14 **under section 3 of this chapter.**

15 (b) The state board shall place the school and the school  
 16 corporation on notice that the school has exceeded the percentage  
 17 of graduation waivers determined under section 3 of this chapter.

18 (c) Upon receiving notice under subsection (b), the school shall  
 19 develop a school-wide remediation plan that follows the guidelines  
 20 established under section 1 of this chapter and submit the plan to  
 21 the department.

22 **Sec. 5. (a) This section applies if, in the second or a subsequent**  
 23 **year after the initial identification under section 3 of this chapter,**  
 24 **a school continues to be identified under section 3 of this chapter.**

25 (b) The state board shall place the school and the school  
 26 corporation on notice that the school has exceeded the percentage  
 27 of graduation waivers determined under section 3 of this chapter.

28 (c) Upon receiving notice under subsection (b), the school shall  
 29 collaborate with the educational service center that serves the  
 30 region in which the school corporation is located to develop and  
 31 implement a revised school-wide remediation plan."

12 **established by the eligible institution, the dual credit teacher shall**  
13 **not submit the grade for the dual credit course to the eligible**  
14 **institution.**".
- 15 Page 13, line 18, delete "Indiana" and insert "**department of**  
16 **education established by IC 20-19-3-1,**".
- 17 Page 13, line 19, delete "state board of education established by  
18 IC 20-19-2-2,".
- 19 Page 13, line 21, after "IC 20-19-4-2;" insert "**and**".
- 20 Page 13, delete lines 22 through 23.
- 21 Page 13, line 24, delete "(3)" and insert "**(2)**".
- 22 Page 13, delete line 26.
- 23 Page 13, line 29, after "completed" insert "**and approved by the**  
24 **Indiana state board of education, established by IC 20-19-2-2,**".
- 25 Page 13, line 29, delete "2013." and insert "**2014.**".
- 26 Page 13, line 30, delete "2014." and insert "**2015.**".
