## **I. STATUTORY DIRECTIVE**

The Indiana General Assembly enacted legislation (P.L. 28-2000) directing the Committee to do the following:

- "(1) Study the safety of rail corridors, including corridors at overpasses, underpasses, and crossings.
- (2) Review railroad safety records.
- (3) Study methods of encouraging cooperation among the railroads, local government, state government, and federal government to enhance the safety of railroads.
- (4) Study other topics as assigned by the legislative council."

## **II. INTRODUCTION**

The Committee met two times during the 2002 interim session on the following dates:

- (1) September 23, 2002.
- (2) October 18, 2002.

The Committee is required to file a final report before November 1, 2005.
