Synopsis: Moratorium on comprehensive care beds and hospitals,. Imposes a moratorium on the construction or addition of: (1) comprehensive care beds; (2) ambulatory outpatient surgical centers; and (3) hospitals; until June 30, 2006.

Effective: July 1, 2004.



A BILL FOR AN ACT concerning health.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. [EFFECTIVE JULY 1, 2004] (a) As used in this
2 SECTION, "comprehensive care bed" means a bed that:

- 3 (1) is licensed or is to be licensed under IC 16-28-2;
4 (2) functions as a bed licensed under IC 16-28-2; or
5 (3) is subject to IC 16-28.

6 The term does not include a comprehensive care bed that will be
7 used solely to provide specialized services and is subject to
8 IC 16-29.

9 (b) Comprehensive care beds may not be added or constructed
10 in Indiana.

11 (c) Residential beds licensed under IC 16-28-2 and unlicensed
12 beds may not be converted to comprehensive care beds.

13 (d) Notwithstanding IC 16-29-3, hospital acute care beds may
14 not be converted to comprehensive care beds.

15 (e) The Indiana health facilities council may not recommend and
16 the state department of health may not approve the certification of
17 new or converted comprehensive care beds for participation in a
18 state or federal reimbursement program, including programs
19 under Title XVIII or Title XIX of the federal Social Security Act
20 (42 U.S.C. 1395 et seq. or 42 U.S.C. 1396 et seq.).

21 (f) This SECTION expires June 30, 2006.

22 SECTION 2. [EFFECTIVE JULY 1, 2004] (a) As used in this
23 SECTION, "ambulatory outpatient surgical center" has the
24 meaning set forth in IC 16-18-2-14.

25 (b) As used in this SECTION, "hospital" means a hospital that
26 is licensed under IC 16-21-2.

27 (c) The following may not be constructed or added in Indiana:

- 28 (1) An ambulatory outpatient surgical center.
29 (2) A hospital.

30 (d) The state department of health may not issue a license under
31 IC 16-21-2 to an ambulatory outpatient surgical center or a
32 hospital. This subsection does not apply to the renewal of a license



- 1 **issued to an ambulatory outpatient surgical center or a hospital.**
- 2 **(e) This SECTION expires June 30, 2006.**
